Description of a 16.63 acre tract

Situated in Farm-lot#5, Section 4, T.8, R.14, Alexander Township, Athens County, Ohio and being more particularly described as follows:

Beginning at a Hickory Stump (rail-road spike set) marking the South-east corner of Farm-lot #5, thence, North 01 Degrees 45 Minutes East, 753.61 feet to an iron pin set in Grantor's East fence-line; thence, along a random-line the following bearings and distances:

South 76°04'30" West, 756.48 feet to an iron pin set;
South 62°38'30" West, 361.28 feet to an iron pin set;
South 49°36'55" West, 153.71 feet to an iron pin set;
South 43°22'18" West, 200.85 feet to an iron pin set;
South 51°51'18" West, 73.84 feet to an iron pin set;
South 71°46'24" West, 85.20 feet to an iron pin set;

South 80°31'34" West, 17.75 feet to a point in Township Road 65; thence, along said road, South 20 Degrees 17 Minutes East, 90.00 feet to a point in Grantor's South-line; thence, along said line, South 90 Degrees 00 Minutes East, 1412.40 feet (passing an iron pin found at 17.8 feet) to the point of beginning and containing 16.63 acres.

Subject to all easements and rights of way of record.

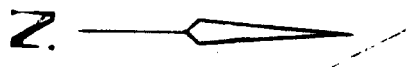

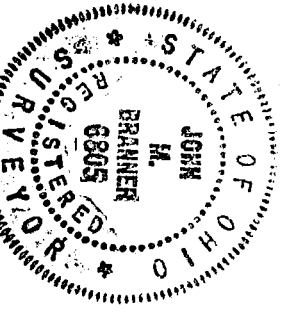
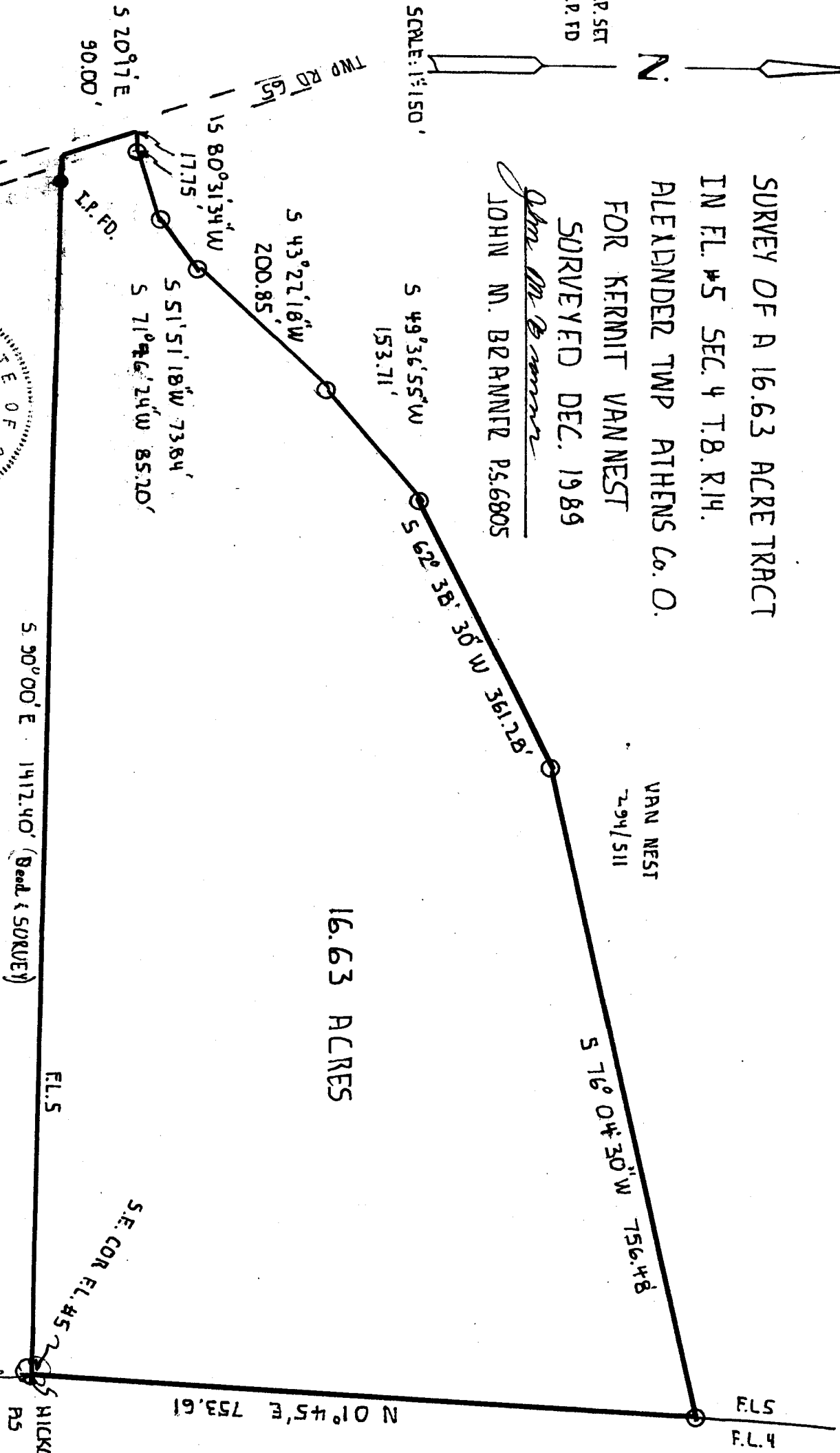
