Commencing at the Northeast corner of F.L. 5; thence N $63^{\circ}21'48''$ W along the North line of F.L. 5, 1,481.7 feet to an iron pipe set in the Grantor's North line, said iron pipe also being the real point of beginning of the parcel herein described; thence S $10^{\circ}05'36''$ W along a random line, 117.73 feet to an iron pipe set; thence N $80^{\circ}31'14''$ W along a random line, 293.97 feet to a railroad spike set in the centerline of Alexander Township Road No. 65 and the Grantor's Westerly line, passing through iron pipes set at 109.91 feet and 274.55 feet; thence the following two (2) courses along the said centerline of Alexander Township Road No. 65 and the said Grantor's Westerly line:
 N $19^{\circ}34'50''$ E, 79.15 feet to a railroad spike set;
 N $26^{\circ}30'00''$ E, 121.03 feet to a railroad spike set in the Grantor's Northwesterly corner and the said North line of F.L. 5; thence S $63^{\circ}21'48''$ E along the said Grantor's North line and the said North line of F.L. 5, 257.38 feet to the point of beginning, passing through an iron pipe set at 15.00 feet, and containing 1.0000 acres.

Subject to all legal highways and easements of record.

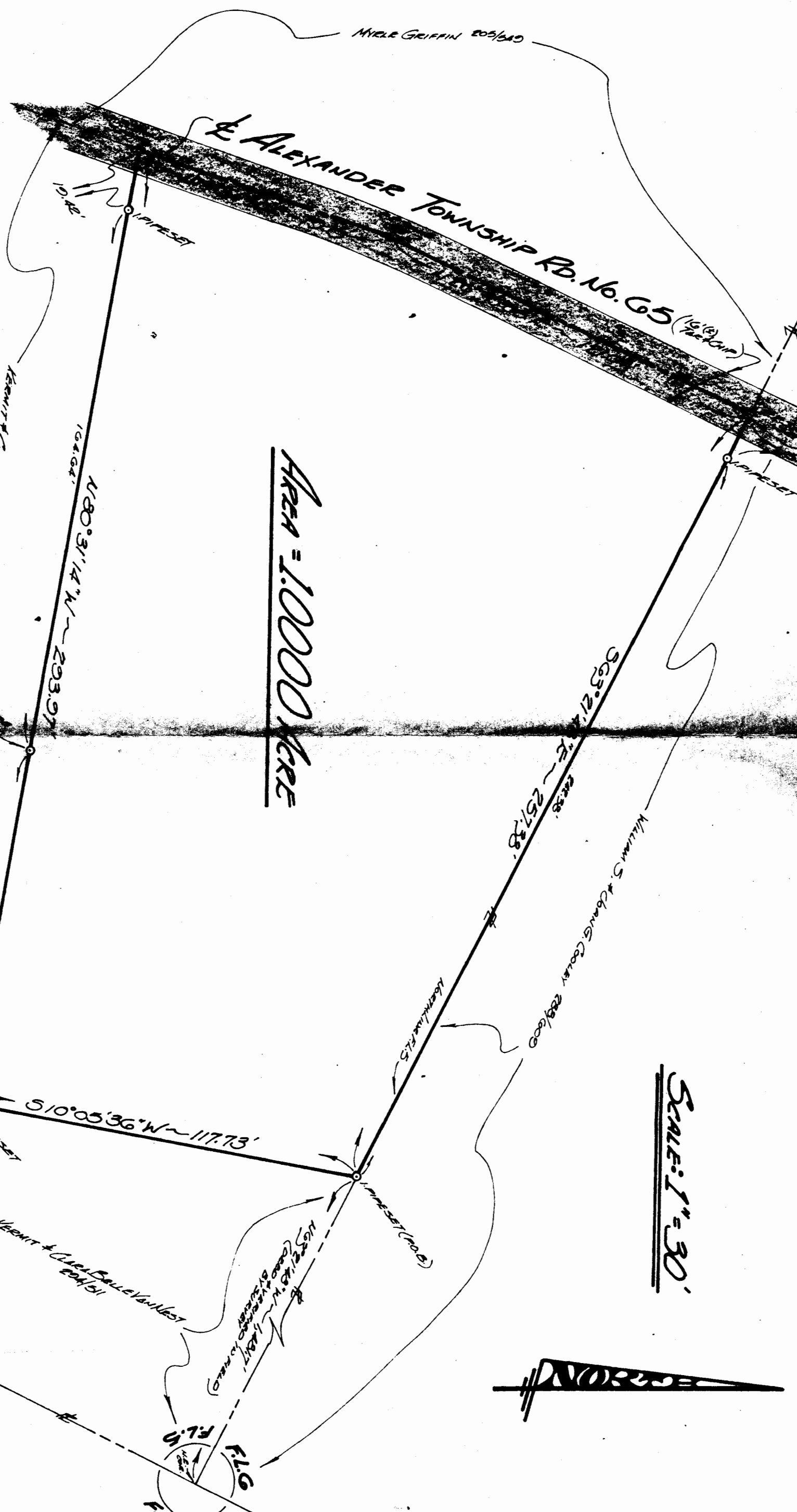
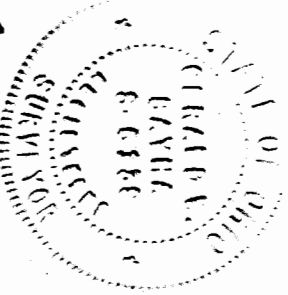
