Thence N 84°50'17" W along the South line of said F.L. 1, 320.15 feet to a railroad spike set in the centerline of Athens County Road No. 21 and the Southeast corner of a 4.23 acre parcel owned by Ramona Miller Guthrie as recorded in Deed Book 240, Page 509 in the Athens County Recorder's Office Athens County, Ohio, said railroad spike set being witnessed by an iron bar found that bears N 84°50'17" W, 20.00 feet from said railroad spike set; thence the following courses and distances along the centerline of Athens County Road No. 21 and the Easterly lines of said 4.23 acre (Guthrie) parcel:

N 09°20'17" W, 177.50 feet to a point;

N 03°55'17" W, 103.50 feet to a point;

N 10°58'23" E, 50.13 feet to a point in the Northeast corner of

said 4.23 acre (Guthrie) parcel, said point being witnessed by an iron bar found that bears S 68°53'43" W, 34.10 feet from said point; thence the following courses and distances along the said centerline of Athens County Road No. 21:

N 14°42'19" W, 157.04 feet to a railroad spike set;

N 13°05'19" W, 119.50 feet to a railroad spike set in the Southeast corner of a 6.7650 acre parcel surveyed in conjunction with the survey described herein;

N 10°29'37" W, 233.24 feet to a railroad spike set;

N 12°02'00" W, 142.38 feet to a railroad spike set;

N 13°08'17" W, 94.78 feet to a point in the Southwest corner of

an 11.9 acre tract owned by Larry A. and Patricia Pratt

as recorded in Deed Book 277, Page 165 in said Recorder's

Office; thence N 81°58'54" E along the South line of said 11.9 acre (Pratt) tract, 475.72 feet to a point in the East line of F.L. 1 and the West line of F.L. 3, said point bearing S 05°08'01" W, 596.04 feet from the Northeast corner of said F.L. 1, passing through an iron bar found at 17.38 feet; thence S 05°08'01" W along the said East line of F.L. 1 and the said West line of F.L. 3, 2,072.23 feet to the point of beginning and containing 15.1047 acres.

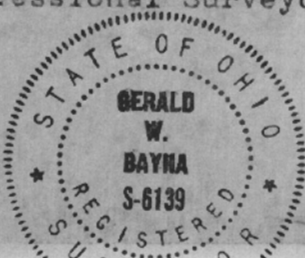

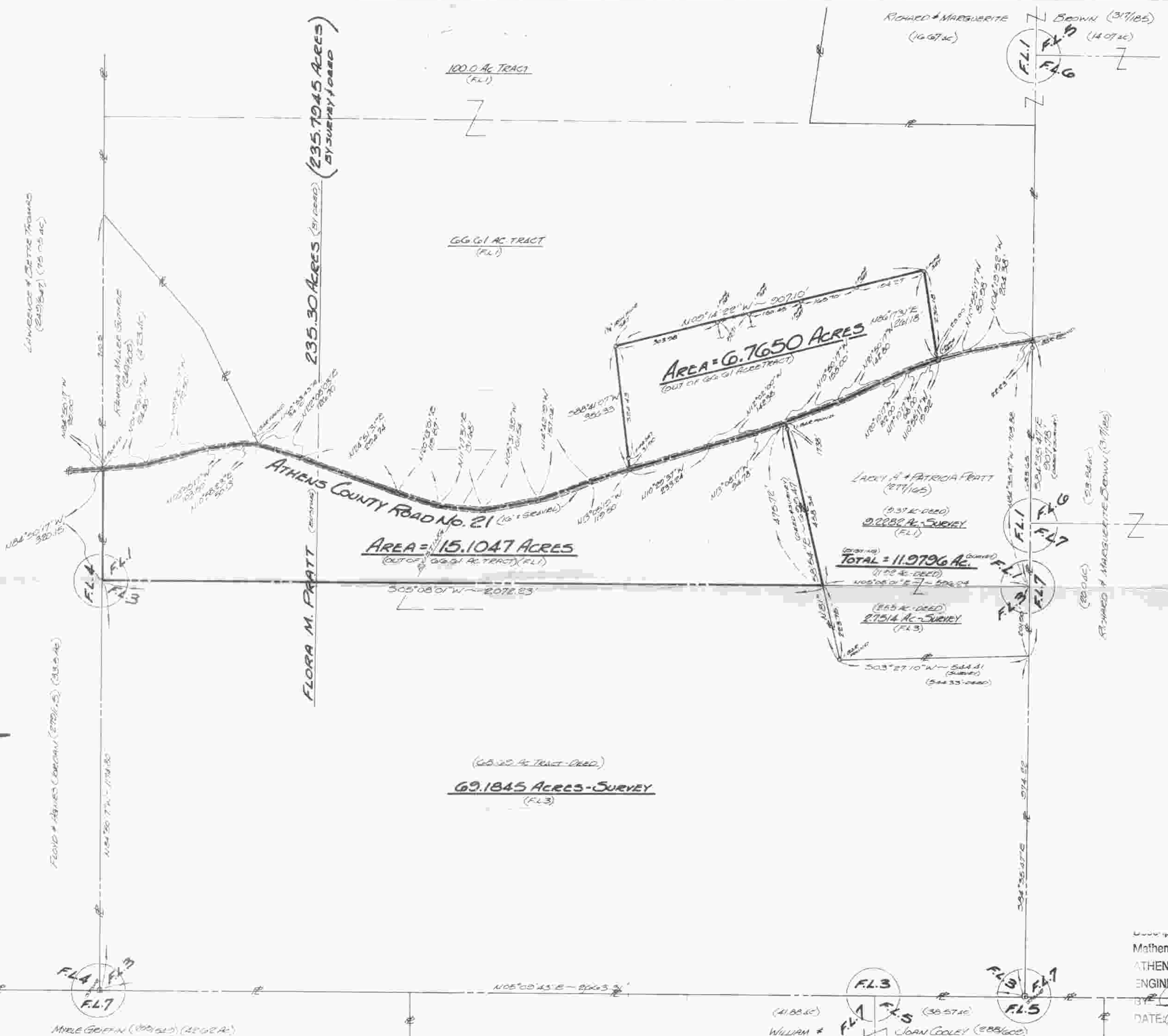
